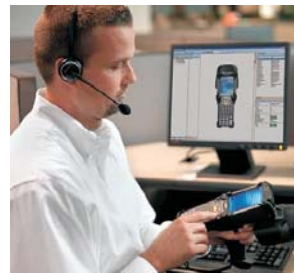

PROGRAM OVERVIEW:

The Wireless School Initiative (WSI) is an Advanced Wireless, Inc. “Corporate Citizenship” program. Established in 2005, the primary goal of the program is to extend into local schools advanced technologies that will provide access to online based curriculum for both students and educators alike. AWI has funded this program for a period of ten years with AWI selecting and awarding a minimum of one school per year for this period of time.

The WSI Award includes:

- Year 1: Up to \$10,000 of enterprise class wireless LAN (WLAN) equipment and services
- Year 2: Technical support services valued at \$3,865
- Year 3: Technical support services valued at \$3,865
- Year 4: Technical support services valued at \$3,865
- Year 5: Technical support services valued at \$3,865

Total Value of Award: \$25,460

School Eligibility Requirements:

In order to be considered for the Wireless School Initiative (WSI) award schools must meet the following requirements:

- Be an accredited public or private elementary, junior high or high school
- Have an existing Ethernet wired LAN infrastructure
- Have a dedicated IT professional on staff
- Commit to providing access to wireless client devices such as laptops, pen tablets, etc. to students and educators and to integrating online instruction tools into general curriculum within one (1) year of WLAN installation
- Provide any cabling and/or hardware mounting services that may be required for implementation of WLAN.

Nomination Process:

To nominate a school for the Wireless School Initiative award, please complete the attached nomination form and submit it with a letter as to why the school is most deserving of the award. All nominations must be submitted by November 1st of each year with the winners being selected in December.
